

MOROCCAN CROSSROADS: MOSQUES, MEDINAS, AND MOUNTAINS

October 16 – November 1, 2020







The Society for Asian Art MOROCCAN CROSSSROADS trip will delve into fascinating Moroccan and Berber cultures and their historic sites, led by our scholar/trip leader, Dr. Trevor Marchand. Dr. Marchand is Emeritus Professor of Social Anthropology at SOAS (the University of Oriental and African Studies, University of London) and has been traveling to Morocco since 1989. He will deliver five lectures and provide ongoing commentary throughout the Morocco trip. Our Moroccan odyssey begins with an overnight in Casablanca.

Casablanca (l night) October 17

Tangier (2 nights) October 18-19

- · Meld of French colonial and Moroccan design
- · Mosques, Kasbah, Palace, Medina and Museum
- Visit art-centered coastal town, Asilah

Chefchaoun (2 nights) October 20-21

 On the way to the charming, blue-rinsed town of Chefchaoun, we stop at the Hispano-Moorish city of Tetouan, at the foot of the Rif Mountains, to visit its Medina *

Fez (4 nights) October 22-25

- On way to Fez, we stop at the Berber village of Tanakoub.
- Full day visiting Fez el Bali* (Old Fez)
- Full day visiting Fez el-Jedid (New Fez)
- Day trip to Spanish-Moorish imperial city of Meknes walking through its medina *

Rabat (2 nights) October 26-27

- Visit to imperial Roman city, Volubilis *
- Visit to Muslim town of Moulay Idriss Zerhoun, one of Morocco's holiest cities
- Explore imperial city of Rabat, capital of Morocco

Marrakech (4 nights) October 28-31)

- Marrakech Explore the narrow medina lanes to discover its main square, Jemass el-Fna Square **
- · Museums, Gardens, Jewish Quarter, Souks
- Spend time in the Atlas Mountains, visit to school and women's cooperative

Difficulty Level: DIFFICULT

Trip participants must be able to climb and descend steep stairs at riad accommodations; walk through congested markets, requiring the ability to move quickly out of the way of heavily-laden donkey carts on narrow, congested cobblestoned lanes; and be able to climb hills and stairs without handrails, when encountered. Trip participants must be able to walk approximately three miles over the course of a day, sometimes on rocky, uneven dirt and cobblestoned paths and stand for extended periods of time in museums and at historic sites - sometimes in the heat of the day. In general, trip participants should be able to keep pace with the group. **PHYSICALLY DEMANDING.**

By signing up for this trip, I acknowledge my full awareness that the visited country (ies) may have a travel warning issued by the US State Department and it is with our complete free will that we are joining that specific tour. I could consult their web site at: www.travel.state.gov. I voluntarily apply to participate in this tour with knowledge of the inherent hazards and risks involved in travel. I also am aware that unforeseen events can happen (completely beyond STS's control) and may also cause the cancellation of the tour or alteration of the proposed itinerary and I accept such risks and the costs involved with it and will not hold STS liable for any damages or losses. As we plan your tour arrangements many months, in advance we may occasionally have to make changes or cancel the whole tour (for lack of participation or for Force Majeur) and we reserve the right to do so at any time. We seldom need to change trip leaders or choice of used airlines and we have the right to do so if necessary. We will accept your tour booking on the understanding that you realize the safety facilities in the developing world - in the vehicles, on the roads and at the tourist sites - often do not match ours in the USA. If you have any valid and legitimate complaint about any of your tour arrangements, you must tell our relevant local supplier at the time. In the event that your complaint cannot be resolved by our local representative at the time, please contact our US office directly. If you fail to follow this simple procedure we will have been deprived of the opportunity to investigate and rectify your complaint whilst you were in the destination and this may affect your rights under this contract for any compensation.

Pausports & Visas. Your passport must be valid for 6 months from the date of return to the USA and must contain empty "Visa" pages. You are also responsible for checking with the appropriate consular sections of the country/ies visited if a visa is required. STS is not responsible for any passport or visa problems, delays or any unforeseen conditions that can affect the trip. Traveler is responsible to provide STS with the valid passport that will be used for the specific trip she/he signed up for and any amendments and changes to the used passport could cause a problem obtaining visas and/or will add additional expenses in resubmittal of information. Upon acceptance of my application this agreement shall be deemed to have been entered into and performed in Eastpointe, Michigan and shall be construed according to the laws of Michigan only. In the unlikely event a legal dispute should arise involving any subject matter whatever, I agree that the dispute shall be settled by binding arbitration through the American Arbitration Association in Michigan. Should the arbitration provision prove to be unenforceable, I agree that any legal action shall be brought before the appropriate court in Macomb County, Michigan, or Federal Court in Michigan. I further agree that should the plaintiff fail to prevail in any legal dispute before a court said plaintiff hereby agrees to pay all reasonable attorneys' fees for the defendant in the dispute.

With regard to credit card sales for services related to this tour, the client will hold STS and its agents and representatives harmless for all charge-backs exercised by them or their credit card companies, originating from any complaints for any unsatisfactory services or for any reason for which the client did not use part of the prepaid tour or for any reasons whatsoever.

<u>Cancellations & Refunds</u>: Cancellations must be received <u>in writing</u>, and will be processed according to the date the written notice is received. Although a verbal cancellation is appreciated, it will not be accepted as final notice. Departure is defined as the date of the first flight from USA, or the trip departure date as indicated on our Trip Schedule, whichever comes first.

1. Money will be refunded minus the following cancellation fees/penalties per person (unless different for a particular trip, then the special cancellation schedule of that trip will apply):
