

Robert and Katherine Jacobs Asian Wing, 8 newly expanded galleries at Detroit Institute of Arts

Space is still available on the Detroit - Ann Arbor trip. We will enjoy a private curator led tour of the newly expanded galleries of the Robert and Katherine Jacobs Asian Wing at the Detroit Institute of Arts, and a private curator led tour of Japanese paintings at the University of Michigan Museum of Art in Ann Arbor. Our trip includes visits to the private homes of two important collectors, one in Detroit and one in Ann Arbor. We will tour the Wright Museum's special exhibition, *King Tutankhamen: Wonderful Things From the Pharaoh's Tomb*, and visit the Detroit studio of contemporary artist Neha Vedpathak, a rising star on the art scene. We'll have a private tour of the Eleanor and Edsel Ford mansion and access to view the beautiful spring blooms in their 8.7 acre lakeside garden. Our trip ends with a farewell dinner at Highlands Restaurant on the 71st and 72nd floors of the Renaissance Center. Check out details in the trip flyer and register before it's too late!

DAY 1: Monday, May 16

Arrive at Detroit Metropolitan Airport and transfer to the hotel independently.

DAY 2: Tuesday, May 17

Morning, Eleanor and Edsel Ford House and Garden. Our private tour of the mansion highlights the Ford's deep love for art and design, and their impressive personal collection of art and antiques. The home remains as it was when they lived in it though originals of many paintings donated to Detroit Institute of Art have been replaced by high quality reproductions. The grounds, gardens, and lakeside landscapes – 87 acres -- are noted for their beautiful Spring blossoms. Thirty-minute commute on private motor coach.

Afternoon, visit a renowned private collection of Japanese prints. Our bus will take us to our host's home and return us to our hotel after our visit.

DAY 3: Wednesday, May 18

Enjoy a full day at Detroit Institute of Arts. The DIA is one of the largest and most significant art collections in the United States with more than 100 galleries and more than 65,000 objects. It has been well endowed by collectors with fortunes from the automotive industry and is ranked one of the top six art museums in the country.



Morning, private tour of eight newly expanded galleries in the Robert and Katherine Jacobs Asian Wing led by DIA's Associate Curator of Arts of Asia and the Islamic World. Works span thousands of years up to the present day in galleries of Japanese, Chinese, Korean, and Indian and Southeast Asian art, as well as a gallery for Buddhist art across Asia.

Afternoon, tour Diego Rivera's masterpiece the Detroit Industry Murals 1932-33. Twenty-seven fresco panels surround the interior Rivera Court. The artist considered these works among his finest.

DAY 4: Thursday, May 19

Enjoy a full day in Ann Arbor. Forty-five-minute commute on private motor coach.

Morning, our private tour of University of Michigan Museum of Art Asian collection led by curator of Asian Art. UMMA is noted for its Japanese painting collection which will be the focus of our tour. The museum is home to the largest collection of Asian art in the state of Michigan.

Our tour will include a visit to the Asian Art Conservation Laboratory to learn about conservation techniques and view some of the current conservation projects.

DAY 5: Friday, May, 20

Morning, visit the studio of contemporary Detroit-based artist Neha Vedpathak. Vedpathak is a multidisciplinary artist renowned for her inventive and original process-based practice and deep connection to her materials. She has had featured exhibitions in the Czech Republic, India, Canada, France, Greece, and the United States. Neha explores the idea of resilience as a common ground between India and Detroit.

Afternoon, visit The Charles H. Wright Museum of African American History. We will tour their special exhibition, "King Tutankhamun: Wonderful things From the Pharaoh's Tomb" which vividly brings to life Egypt's 18th Dynasty. The installation features more than 120 replicas of Pharaoh Tut's personal and sacred possessions highlighting his opulent lifestyle in both life and death. It includes his throne, chariot, funerary mask, bejeweled royal mummy and much more.
