SAA: Asian Art and Heritage in Kansas City

Overview

Please join the Society for Asian Art tour to Kansas City for visits to extraordinary collections of Asian art. Kansas City is home to The Nelson-Atkins Museum of Art, whose Chinese art collection is considered one of the top three museum collections in the U.S., with one of the largest scroll collections outside of Asia. It also has more than 1,100 objects of South and Southeast Asian art, Himalayan art and Islamic art from West Asia. Curator-led tours will showcase collections representing a wide range of art forms, including sculpture, ceramics, textiles, metalwork, and works on paper that date from the 3rd century B.C.E. to the 21st century C.E. We will also see special exhibitions focusing on the royal thrones in silver of Dungarpur, contemporary Chinese-American works of art, and traditional works of Japanese art, not to mention the blockbuster traveling exhibition of sculpture by modernist Alberto Giacometti. Next, we will travel an hour west to the University of Kansas to visit the Spencer Museum of Art, which has a remarkable collection of Asian art in renovated and reinstalled galleries. Also spend an afternoon with the owners of the best private Asian art collection at their home in rural Missouri. Round out our time in Kansas City with tours and visits to other well-known museums -- from the Kemper Museum of Contemporary Art to the American Jazz Museum - as well as the lesser-known ones such as the Thomas Hart Benton House and Arabia Steamboat Museum. Our base for five nights will be the historic Raphael Hotel near The Country Club Plaza with its many shops and restaurants.

Itinerary

Check-in to **The Raphael Hotel** for five nights. Built in 1927, this landmark hotel originally served residents of Villa Serena Apartments. In 1975 it was transformed into one of Kansas City's most beloved boutique hotels, with spacious rooms and updated features. Chaz, a cozy, clubby restaurant on the lower level, features live jazz from Sunday to Thursday from 6 to 10 p.m.

The hotel is located steps from shops and restaurants in Country Club Plaza, the country's first planned shopping center, designed in Spanish Mediterranean style and dotted with fountains.

10:00 a.m. Nelson-Atkins Museum of Art, known for its encyclopedic collection of art from nearly every continent and culture. www.nelson-atkins.org

The museum is distinguished (and widely celebrated) for its extensive collection of Asian art, especially that of Imperial China. Most of it was purchased in the early 20th century by Laurence Sickman, then a Harvard fellow in China. The museum has one of the best collections of Chinese antique furniture in the country, including a group of glazed pottery luohans from Yixian (c. 1000). In addition to Chinese art, the collection includes pieces from Afghanistan, Japan, India, Iran, Indonesia, Korea, Pakistan, and Southeast and South Asia.

Our line-up today will include these curator-led tours:

Kimberly Masteller, Ph.D., Jeanne McCray Beals Curator of South and Southeast Asian Art, will lead a tour of the Indian galleries, including two period rooms -- a "Persian Room" and the "Hindu Temple Room." Sculpture is one of the great strengths of the collection, which features excellent examples of stone, bronze and metal sculpture from India, Nepal, Tibet, ancient Gandhara (modern Pakistan and Afghanistan) and peninsular Southeast Asia. The museum also is home to a small but significant collection of works on paper representing the Persian, Mughal and Rajput traditions.

She will also take us through the special exhibition:

Silver Splendor: Conserving the Royal Thrones of Dungarpur, India

In 1911 the Maharawal (ruler) of Dungarpur, a small kingdom in the western state of Rajasthan, commissioned these European-style thrones and related objects for use in a new royal palace. 1911 was also the year of the British King George V's coronation as Emperor of India, an event celebrated by a grand Durbar (court assembly) and King-Emperor's tour of India. Given the date, the thrones were likely created to receive dignitaries in Dungarpur during this year of tours and celebrations. A former Dungarpur king brought the thrones to Europe in 1969 and the Nelson-Atkins acquired them in 2013. Since then, the museum, with local and international partners, restored these objects, using a combination of advanced technologies and traditional Indian art forms to give a sense of their original appearance.

Ling-en Lu, PhD., Associate Curator, Chinese Art, will lead a tour of the Chinese galleries, as well as the special exhibition, *Found in Translation: Explorations by 8 Contemporary Artists*, which she co-curated. The art in *Found in Translation* is informed but not defined by artists' individual experiences with immigration from places across Asia to the Kansas City region. It reflects their perspectives on the world and their places in it, shaped through a range of styles and media. These eight artists use their practices to explore evolving personal questions tied to place, memory, relationships, and other complex topics. Among local artists for this exhibition are Shreepad Joglekar, Hyeyoung Shin, and Hong Chun Zhang.

Yayoi Shinoda, Curator of Japanese Collections, will provide a tour of the special exhibition, *Traditions of Japanese Art*. It highlights distinct aspects of arts and culture cultivated in Japan through more than fifty objects of wide-ranging media from the museum's permanent collection. Those works created in the last 1,300 years embody people's spiritual practices and active engagements with theaters and the natural world. They also present how visual art traditions emerged and evolved through the people's interactions domestically and globally. Light-sensitive objects, including works on paper and textiles, are rotated throughout the year.

LunchNo host lunch at the museum's Rozelle Court Restaurant.The restaurant offers self-service dining with signature salads, sandwiches, soups,
breads and desserts changed seasonally to utilize the freshest ingredients.

Afternoon See the special exhibition: Alberto Giacometti: Toward the Ultimate Figure (runs March 18 – June 18, 2023). Tickets will be pre-purchased and included in the Tour Price.

Enter the mind of modernist sculptor Alberto Giacometti in his search for a new vision of the human form. Featuring more than 100 bronze portrait busts, towering statuettes, paintings, sketches, and prints, this exhibition documents the iconic explorations and visionary achievements of this internationally celebrated artist of the postwar era. Visit Giacometti in his famed Paris studio in scenes captured by noted photographers including Richard Avedon, Henri Cartier-Bresson, Robert Doisneau, Gordon Parks, and Irving Penn, offering glimpses into his life and tireless pursuit to reveal our fragile yet resilient humanness.

Return to the hotel on your own. The museum remains open until 5 p.m.

He retired as Director and CEO of the Nelson-Atkins in 2010 (prior to that he was its Asian Art curator). She trained as an art historian and taught Chinese and Japanese art before opening Asiatica, a shop specializing in garments created

from vintage Japanese kimono fabrics and offering unique antiques and fashion items gathered during her regular trips to Japan. The contemporary house the couple built in rural Platte County, MO, is a restful repository of objects collected over a shared lifetime of global travel and study. A delight in the beautiful and unusual and an eye for the aesthetics of the commonplace unifies widely disparate treasures, including Pre-Columbian textiles, Chinese furniture, Japanese folk art, rocks and minerals, antique tools, Modern painting and sculpture, contemporary prints and photography.

Located in the historic City Market, the Arabia Steamboat Museum houses artifacts salvaged from the *Arabia*, a steamboat that sank in the Missouri River in 1856. It is said to be the largest single collection of pre-Civil War artifacts in the world. From clothing, fine china and carpentry tools to guns, dishes and children's toys to the world's oldest pickles—the collection is a veritable time capsule.

When visitors enter the museum, a series of four 5-minute videos recount the history of the *Arabia*'s sinking and excavation. An additional 14-minute film called *The Fall and Rise of the Steamboat Arabia*, may also be viewed in the theater. Next, guests view the artifacts on display, as well as an open preservation lab where staff members work on cleaning the many artifacts in storage. Finally, visitors walk a 171-foot-long full-scale reproduction of the *Arabia*'s main deck, where they can see archival footage of the excavation process and more information about its history, along with the original boilers, engine, anchor, and the skeleton of a mule. Also on display are the 6-ton stern and a reconstructed paddle wheel.

- 1:30 p.m. Docent-led tour at the Kemper Museum of Contemporary Art. The permanent collection often shows works by artists of Asian heritage — Hung Liu, Roger Shimomura and Gajin Fujita, among them, and *Genie (Peonie) 2019* by Jiha Moon is currently on display. ADDRESS: 4420 Warwick Blvd.

The museum preserves the history of American jazz music, with exhibits on Charlie Parker, Duke Ellington, Louis Armstrong, Ella Fitzgerald and others. Kansas City Museum, a recently re-opened house museum that reflects the story of Kansas City.

In 1910, the site was built by lumber baron and civic leader Robert A. Long as his private family estate, with the four-story historic Beaux-Arts style mansion named Corinthian Hall. In 1940, the site was donated by Long's heirs to become a public museum. Corinthian Hall opened to the public following its restoration in October 2021, and displays some 400 artifacts plus numerous images from the museum's archives, exhibits, media, and site-specific art installations by Kansas City-based artists. The Museum is embarking on restoration of the conservatory and carriage house, slated to open in 2024 and 2026, respectively.

National World War I Museum and Memorial

The museum focuses on global events from the causes of World War I before 1914 through the 1918 armistice and 1919 Paris Peace Conference. Visitors enter the exhibit space within the 32,000-square-foot (3,000 m²) facility across a glass bridge above a field of 9,000 red poppies, each representing 1,000 combatant deaths.

NOTE: The combo ticket includes General Admission (access to the Main Gallery and Exhibit Hall) and admission to the Liberty Memorial Tower, the best view in Kansas City. Guests can take an elevator, followed by 45 stairs, to the open-air observation deck at the top of the Liberty Memorial Tower for a breathtaking 360° view of the Kansas City skyline.
